This Privacy Policy is applicable to all websites operated by **Retail Value Chain Federation (RVCF)** (referred to herein individually and in the aggregate referred to as "Company", "we" or "our") Internet websites.

### **Website Practices**

We do not seek to collect personally identifiable information from website visitors, except (a) when they have provided such information in connection with registration for free or paid services, submission of content, community postings, etc., ("Subscribers"); or (b) if we suspect our websites are being misused.

We do collect website visitor IP addresses and domains, which we may use for analysis, marketing or for security purposes.

Subscribers may be required to provide their business contact information and, if they are purchasing services, their approval of a mandatory on line "click through" agreement governing the use of these services, and their credit card information for payment. Subscribers will be issued personal logon IDs and passwords.

Cookies. After a Subscriber has logged in to the Services with a user name and password, we use "Cookies" to identify you during the course of the session, and to facilitate access to and use of the site. Upon the termination of the session the cookie will be deleted, or retained, as you choose, in your browser.

### **Information Use**

The personally identifiable Subscriber information that we collect is used to complete requested transactions, provide our services, update our databases, and provide Subscriber support, and you agree we may contact you for these purposes, as well as for related marketing promotions and new services. If you do not wish to receive these communications, we encourage you to opt out of any further receipt by following the opt-out provisions provided in each such communication. When you sign up for access to our website, your personally identifiable information, including your e-mail will automatically be added to our mailing list.

We may use accountants and legal counsel, as well as outside contractors to support our administration, operations, systems or websites who, in providing their service, may use the information in accordance with this policy.

Also, Subscribers and visitors should be aware that when third parties offer subscription and/or registration-based services accessed through our website. We also provide information to credit card processors, if applicable. We are not responsible for any actions or policies of such third parties and visitors should check the applicable privacy policy of such party when providing personally identifiable information.

RVCF has been opted-in to "The LeadLander Contact Network." LeadLander is a web analytics tool, similar to Google analytics. However, The LeadLander Contact Network pools together

contact information collected through any rvcf.com forms or e-mail campaigns and any other LeadLander opted-in website forms or e-mail campaigns to identify a visitor to the rvcf.com website. Whenever a visitor goes to ANY LeadLander opted-in website, LeadLander can display the visitor by their name and e-mail address in its reports.
